



## Introduction

### The history of Salford CVS

Salford Council for Voluntary Services was established in Salford in 1973.

Originally operating as a co-operative, the structure began to change in 2001 when it appointed its first Coordinator, closely followed in 2002 with its first Chief Executive Officer. The organisation was incorporated as a Company Limited by Guarantee in 1985 and registered as a Charity in 1988. In 2008 the organisation was renamed **Salford Community and Voluntary Services (Salford CVS)**.

Salford CVS is the city-wide infrastructure organisation for the voluntary, community and social enterprise sector; providing specialist information, advice, development support and opportunities for influence and collaboration. We provide support for organisations to establish and develop including providing training for their staff, volunteers and trustees. Via our Volunteer Centre we provide support for individuals who want to volunteer and assistance for organisations with developing their volunteering programmes.

Salford CVS operates within a wider framework in terms of our membership of NAVCA, NCVO and Social Enterprise UK nationally and our membership of 10GM and GMCVO at city-region level.

Salford CVS has a proud history of making a difference in Salford for over 40 years. We are a well-respected partner in this city and have excellent relationships with both VCSE and public sector organisations. We are financially stable with a clear business plan and a highly skilled, motivated staff team and board of trustees. As a membership organisation we work hard to address the needs and represent the interests of our hundreds of Voluntary, Community and Social Enterprise (VCSE) member organisations.

## Who We Are

As a membership organisation, Salford CVS' key relationships lie with its member organisations and with the wider VCSE sector in Salford – which comprises 1,516 voluntary, community and social enterprise organisations (Salford State of the VCSE Sector 2017, Sheffield Hallam University).

Salford CVS currently has in the region of 700 members – all of whom are organisations from the voluntary, community and social enterprise sector in Salford.



The organisation is governed by a Board of Trustees who are elected by members at our annual general meeting. The Board comprises people who predominantly live and / or work in Salford and who have relevant skills and experience to share.

Each year the elected Board appoints a Chair, Vice Chair and Treasurer from amongst its Trustee team.













### **GRANTS AND INVESTMENTS**


We manage and administer a wide range of small grants and investments, such as:

## The Sector in Salford

### Salford State of the VCSE Sector 2017 report

In 2016 Salford CVS once again led a piece of work across Greater Manchester to ascertain how the VCSE sector was doing – in terms of income, activity, staff and volunteering, relationships, and so on. Working with colleagues from 10GM and GMCVO we created a comprehensive survey, which we then asked a wide range of voluntary organisations / charities, community groups and social enterprises to complete. We then recommissioned Sheffield Hallam University's Centre for Regional Economic and Social Research (CRESR) to analyse and summarise the findings. We also conducted some focus groups in person in order to delve further. In June 2017 the GM and locality reports were launched, including the Salford report.

Some of the Salford key facts we identified from the research:

- 1,513 voluntary organisations, community groups and social enterprises making a difference in Salford – making 2.4m interventions p.a.
- 69% are micro organisations (annual income under £10k)
- 14% identify as being a social enterprise
- £165m total income of the sector (2014/15)
- 43% have less than 3 months running costs in reserve
- 5,300 paid employees in the sector (3,500 fte)
- 46,800 volunteers giving 115,400 hours p.w., valued at £104.4m p.a.

#### Salford VCSE Manifesto 2016 - 2021

Also in 2016 Salford's VOCAL VCSE Leaders Forum members developed a Manifesto for the VCSE sector in Salford.

This manifesto featured 6 'asks' for our public sector colleagues, known as the 6 Pillars: INVOLVE, INCLUDE, COLLABORATE, VALUE, INVEST, END POVERTY.

The Manifesto was refreshed in 2017 and stands now as a 5-year 'ask'.

### Salford VCSE Strategy 2018 - 2021

2017 saw Salford CVS working with VCSE colleagues from the VOCAL VCSE Leaders Forum alongside colleagues from Salford City Council and NHS Salford CCG to draft a response to this Manifesto, which became a VCSE Strategy for Salford.

This 3-year strategy and its associated action plan provides a response and way forward in relation to each of the 6 Pillars and will be launched in summer 2018.











## The Future

The next five years are likely to bring yet more challenges - for Salford CVS; for the wider voluntary, community and social enterprise sector; for the city of Salford as a whole; and ultimately for its residents.

Whilst we haven't got a crystal ball, the factors that will influence our work over the next five years are likely to include:

- Impact of continued austerity including probable further cuts to local government budgets
- Roll-out of more cuts to social security benefits ("welfare reform")
- Brexit and the aftermath of leaving the European Union
- A general election
- Changes and challenges in health and social care
- The way 'services' are commissioned by the public sector
- The changing demographics of Salford
- Implementation of Greater Manchester Devolution
- Growth (in Salford and across GM) will it be inclusive or exclusive?
- The housing crisis ensuring enough social and affordable housing exists
- Securing good employment opportunities for local people (including the accredited Living Wage)
- Northern Powerhouse opportunity for transformation or white elephant?
- Transport and infrastructure fit for the 21st Century

In 2017/18 Salford CVS fully reviewed its strategic priorities with a wide range of stakeholders in order to ensure they were demand responsive and fit for purpose as we go forward.

Over the next 5 years Salford CVS will continue to work in partnership across the sectors - VCSE, public and private - to get the best deal for local people.

This will include seeking appropriate resources for all segments of our diverse voluntary, community and social enterprise sector. We'll continue to advocate around the value of volunteering and promote social value and the Salford 10% Better campaign. We'll keep making the case for the VCSE sector to be recognised as a key strategic player and a key delivery player in this city. We'll be ensuring implementation of the Salford VCSE Strategy is meaningful and transformational and that the new Health & Social Care MoU leads to an enhanced role for our sector in supporting person and community-centred approaches to wellbeing, health and care. As a charity, tackling poverty will remain at the heart of all that we do.

### **Strategic Priorities**

As you can see above, we have decided to focus on 6 distinct themed areas of work as our strategic priorities in the years 2018 - 2023.

These themes have emerged from feedback gleaned from our VCSE sector colleagues, including current users of our existing services; via the VOCAL VCSE Forums we facilitate; from our strategic work with key partners from across sectors in both Salford and Greater Manchester; from reviewing other key strategies such as Salford's Locality Plan, Tackling Poverty Strategy, Employment and Skills Strategy, Volunteering Strategy, and so on; from our work as core members of Salford Social Value Alliance and Salford Social Enterprise City; and last but not least, utilising intelligence gleaned from our own staff and trustees.

Each themed area has 3 strands of work against which we will deliver our services. These 18 work strands will form our annual operational plan, against which we will report our achievements and impact in our annual report and at our public AGM. These will be reviewed annually.
