The History of Salford CVS

Background

Salford CVS began life in 1919, as part of Manchester and Salford Council for Social Service (MSCSS). The organisation covered the twin cities of Manchester and Salford and was established to support local people by coordinating relief efforts and taking practical action in the aftermath of World War One.

Salford Council for Voluntary Services was established in Salford in 1973, in response to local authority changes, when MSCSS split into two organisations – Salford CVS and Manchester CVS. Originally operating as a co-operative, the structure began to change in 2001 when it appointed its first Coordinator, closely followed in 2002 with its first Chief Executive Officer. The organisation was incorporated as a Company Limited by Guarantee in 1985 and registered as a Charity in 1988. In 2008, the organisation was renamed Salford Community and Voluntary Services (Salford CVS).

Our role in Salford

Salford CVS is the city-wide infrastructure organisation for the Voluntary, Community and Social Enterprise (VCSE) sector in the city of Salford; providing specialist information, advice, development support and opportunities for influence and collaboration. We provide support for organisations to establish and develop including training for their staff, volunteers and trustees.

Via our Volunteer Centre, we provide support for individuals who want to volunteer and assistance for organisations with developing their volunteering programmes.



Salford CVS has a proud history of making a difference in Salford for over 100 years. We are a well-respected partner in this city and have excellent relationships with both VCSE and public sector organisations. We are financially stable with a clear business plan and a highly skilled, motivated staff team. As a membership organisation we work hard to address the needs and represent the interests of our over one thousand Voluntary, Community and Social Enterprise (VCSE) member organisations.

The organisation is governed by a Board of Trustees who are elected by members at our Annual General Meeting. The Board comprises of people who predominantly live and/or work in Salford and who have relevant skills and experience to share. Each year the elected Board appoints a Chair, Vice Chair and Treasurer from amongst its Trustees.

Our role in Greater Manchester

We play a strategic role in the Greater Manchester city-region, where we are founder members of the GM VCSE Leadership Group, created in response to devolution. We are founder co-owners of the 10GM partnership (www.10GM.org.uk), alongside Action Together, Bolton CVS and Macc; and work closely with all of the local infrastructure organisations in Greater Manchester.

Vocal Forums


Our Vocal Forums provide strategic VCSE voice and influence, and include leaders (Chief Executives); children, young people and families; and wellbeing, health and care. We also facilitate several practitioner networks around domestic abuse and sexual violence, environment, food, and volunteer coordinators. We operate with the support of a wide range of Vocal representatives from the VCSE sector, who sit on a variety of partnership boards in the city on behalf of our sector.

Strategic Partnerships

Salford CVS and Vocal representatives actively participate in all of the city's strategic partnerships as advocates for the VCSE sector, volunteering and local communities – including the Health and Wellbeing Board, Skills and Work Board, 0-25 Advisory Board, Safeguarding Adults Board, Safeguarding Children's Partnership, Community Safety Partnership, Equality Network, Climate Action Board and many more. We are also members of NHS Greater Manchester Integrated Care Partnership Board structures both locally and within Greater Manchester.

Conferences and round table events

Salford CVS convene a range of round table events for our sector throughout the year, featuring key council and health leaders; we also organise a large VCSE conference each year and a Seldom Heard young people's event, to name a few.

Capacity Building

Development Support

We provide one-to-one information, advice and guidance, group support and training courses to the VCSE sector. This includes good governance, financial management, sourcing funding, support for social enterprises, strategic and business planning, demonstrating impact, social value, equalities, safeguarding, data protection, using data and stats and campaigning.

Grants and Investments

We manage and administer a wide range of small grants and investments in Salford and across Greater Manchester, such as the NHS GM supported Third Sector Fund grants programme; Salford City Council's Short Break Care, Family Hub and Hate Crime grants; GM Mental Health Trust's Asset Recovery Fund; GMCA's Inspire grants; GM Moving's Walking and Wheeling grants, and other funds.

Back Office Services

- Finance bookkeeping, management accounts, independent examinations, payroll and provision of holding accounts
- Administration printing and copying
- Compliance DBS checks and advice, help with auto-enrolment (pensions), GDPR (data protection), information and training
- Other Services such as providing a postal address service for small community groups and operating a range of consultancy services

Volunteering

Volunteer Centre

Volunteer Centre Salford provides a range of services including Volunteering Brokerage, Good Practice support, Training, Strategic Development, Campaigning and Recognition. We also run our annual Heart of Salford awards.

Our Volunteers

We look after a large number of volunteers directly who provide support to Civil Contingency emergencies, Age Friendly Salford and Family Hubs, for instance.

Continue to undertake emergency response and civil contingencies work in Salford and GM

Provide 1-2-1 capacity-building support for Salford's VCSE organisations, specifically focusing on good governance, business planning, securing funding, compliance, safeguarding



Organise a wide range of training workshops on key themes, taking place throughout the year; including delivering adults and children's safeguarding training



Manage and administer a wide range of small grants and investments to benefit the local VCSE sector

Support new members through the grants process – we'll do this via our 'Meet the Funder' events and follow up with 1-2-1 support as needed




Offer training for volunteers in youth work, community development, mentoring and other relevant skills — we'll research this as part of the refresh of our training offer for 2025/26




Prioritise developing volunteering opportunities for Salford's young people and residents from diverse communities, ensuring good practice is at the heart of this work
